

### IMPORTANT SAFETY RECALL

This notice applies to your 2023 Grand Design Transcend 235BH

Dear Grand Design RV Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Grand Design RV has decided that a defect, which relates to motor vehicle safety, exists in certain 2023 Grand Design Transcend travel trailers. An emergency exit window was not installed in the main living area of your recreational vehicle. Were an emergency to occur, occupants of the vehicle would have no emergency exit option other than the entrance door in the main living area. This could lead to an increased risk of personal injury.

#### ! IMPORTANT!

- Your vehicle falls within the recall population.
- You should immediately schedule an appointment with your dealer to have your vehicle inspected and, if necessary, have the emergency exit window installed.

### Why is a recall being conducted?

On select model **Grand Design Transcend 235BH** recreational vehicles manufactured between **June 16, 2022, and November 30, 2022**, an emergency exit window may not be installed in the main living area. If an emergency were to arise, occupants of the vehicle would have no emergency exit option other than the entrance door in the main living area. This could lead to an increased risk of personal injury.

## What are we doing about the problem?

On affected vehicles, the standard window will be replaced with a safety approved, emergency exit window. Grand Design dealers have been notified of this recall and have the required repair instructions available. Repair is estimated to take no more than 1 hour. There will be no charge for this service.

#### What should you do?

Please contact your selling or nearest Grand Design RV dealer as soon as possible to schedule an appointment. If your distance from a Grand Design dealer is significant, please contact us at 574-825-9679 and choose the "Recall" prompt or email <a href="recall@granddesignrv.com">recall@granddesignrv.com</a> We can discuss other arrangements to have the needed inspection & repairs completed.
